

**MINUTES OF THE DECEMBER 5, 2023 MEETING OF THE
HARRIS-FORT BEND EMERGENCY SERVICES DISTRICT NO. 100**

A Meeting was duly called of the Board of Commissioners of **HARRIS-FORT BEND EMERGENCY SERVICES DISTRICT NO. 100**, which was held, **DECEMBER 5, 2023**, at the offices of the District Training Center, 16005 Bellaire Blvd., Houston, Texas 77083.

The District considered and acted upon the following matters:

The meeting was called to order at 6:16 p.m. by Dale Terry, Board President, who announced that a quorum was present. Those Commissioners present were: **DALE TERRY, STEVE FOWLER, MARY BLONDELL, JEFF JERNBERG** and **KEN ARRINGTON**. Also, in attendance was Fire Chief Bobby Clark, Assistant Chief **Johnny Mitchell**, and Assistant Chief **Josh Taylor** of Community Protection Agency, Inc., (referred to herein as the "Department" and commonly known of as Community Volunteer Fire Department"), and David Manley of Coveler & Peeler, P.C., the District's legal counsel.

The Board proceeded to address the following:

2. To receive public comment.

None.

3. To review, discuss and act on approval of prior meeting minutes.

4. To review, discuss and act on payment of District operating bills and take action on District Investments and any necessary banking authorizations and pledge agreements.

A Motion was made by Ms. **BLONDELL**, seconded by Mr. **ARRINGTON** to approve and pay the bills as presented. After review and consideration, the Motion passed 5 to 0.

5. To receive an operations and financial report from Community Volunteer Fire Department, and to take any necessary action thereon, including to receive and approve the Department payroll and expense totals from the previous month.

Chief Clark provided a summary of responses and activity. After review, a Motion was made by Mr. **JERNBERG**, seconded by Mr. **ARRINGTON**, to accept the reports and approve reimbursement of payroll expenses in the amount of \$588,102.02, operational expense in the amount of \$678,339.46 and to transfer \$1,750,000 to the Department to cover December and January expenses. After discussion, the Motion was approved by a vote of 5 to 0.

6. **To receive a report from Conclusive Coding regarding the District's social media presence as well as other assigned projects.**

Mr. Parrent was unable to attend. No action taken.

7. **To review and act on disposal of surplus equipment.**

8. **To review, discuss and take action on acquisitions or needed repairs to the District's supplies, equipment, vehicles or apparatus.**

9. **To review, discuss and take action on construction, needed improvements or repairs to the District's facilities.**

Chief Mitchell notified the Board that Station 1 had roof leak that has been fixed, and that the installation of the new gate at Station 3 is almost complete. A motion was made by Ms. **BLONDELL**, seconded by Mr. **FOWLER** to proceed with the demolition of old Station 1 and the tower and let the property revert back to the school district. After review and discussion, the Motion passed by a vote of 5 to 0.
