

## NOTICE OF ELECTION

**TO: THE QUALIFIED VOTERS OF HARRIS COUNTY, TEXAS, AND FORT BEND COUNTY, TEXAS WHO RESIDE IN HARRIS-FORT BEND EMERGENCY SERVICES DISTRICT NO. 100:**

The Board of Emergency Services Commissioners of HARRIS-FORT BEND EMERGENCY SERVICES DISTRICT NO. 100 has issued an Order calling for an election to be held on May 3, 2025 from 7:00 A.M. to 7:00 P.M., at which election all eligible voters residing within the boundaries of HARRIS-FORT BEND EMERGENCY SERVICES DISTRICT NO. 100 will be entitled to vote on the following:

### **Annexation – Texas Health and Safety Code § 775.0751**

#### **Proposition A:**

FOR

Adding the area commonly known as Fieldstone Subdivision, a portion of the Long Meadows Farms subdivision located north of Grand Parkway (State Highway 99), and a portion of Grand Mission Estates west of Mason Road, which lie within the boundaries of Fort Bend County, Texas, to the Harris-Fort Bend Emergency Services District No. 100.

AGAINST

**LOCATIONS OF POLLING PLACES:** Qualified voters residing in the Harris-Fort Bend Emergency Services District No. 100 may vote in the appropriate polling place locations designated for the election. The consolidated county election precincts and the respective Election Day polling places are described in Attachment 1, below.

**EARLY VOTING:** Early voting shall be conducted by **Johnny Mitchell**, the Early Voting Clerk, from April 22, 2025, through April 29, 2025. During early voting, a voter may vote at any of the Early Voting polling places as described in Attachment 2, below.
