- 7. To review, discuss and act on acquisitions or needed repairs to the District's equipment, vehicles or apparatus.
- 8. To review, discuss and act on improvements or repairs to the District's stations or related facilities.
- 9. To review, discuss and act on matters related to operation of dispatch center.

- 14. To take action on matters discussed in closed session.
- 15. To confirm the dates for upcoming meetings, and address items for inclusion on future agendas.
