This Pre-Solicitation Meeting Announcement is intended solely to inform the construction industry of an upcoming procurement opportunity and to facilitate informal engagement and Q&A. ESD 100 seeks to determine the availability of qualified, capable, and interested sources to support procurement planning.

This meeting's purpose is to share project goals, gather market feedback, and answer questions regarding the construction of the Houston STORM Facility, a state-of-the-art municipal aquatic training center focused on swiftwater rescue in Texas. No award will be made based on participation in this event.

### **Project Requirement Details**

ESD 100 is working to engage the construction industry in a fair, transparent, and collaborative manner to develop the procurement strategy for the Houston STORM Facility. This pre-solicitation meeting is part of that strategy and aims to inform, assess market interest, and allow construction firms to decide how they plan to pursue the upcoming Bid Solicitation.

### **Project Background**

The Houston STORM (Swiftwater Training Operations and Rescue Management) Facility will be the second municipal whitewater training center in the U.S. designed specifically for urban swiftwater rescue. The 27-acre facility includes:

- A 7.2-million-gallon recirculating swiftwater rescue course with two engineered channels constructed of reinforced, watertight concrete over a geosynthetic membrane
- A simulated urban streetscape and village
- A lower pond area adjacent to the channels
- Eleven support buildings ranging from ~2,500 SF to ~34,000 SF

- Multiple vehicular and pedestrian bridges
- Onsite utilities including water, sanitary sewer, storm drainage, and a raw water line
- Associated site improvements, including parking, hardscape, and landscaping

This project responds to the increasing need for realistic, high-impact emergency responder training due to flood-related disasters while maintaining a level of control and safety not available at current training sites in active waterways.
