## MINUTES OF THE MAY 6, 2025 MEETING OF THE HARRIS-FORT BEND EMERGENCY SERVICES DISTRICT NO. 100

A Meeting was duly called of the Board of Commissioners of **HARRIS-FORT BEND EMERGENCY SERVICES DISTRICT NO. 100**, which was held, **May 6, 2025**, at the offices of the District Training Center, 16005 Bellaire Blvd., Houston, Texas 77083.

The District considered and acted upon the following matters:

The motion was approved by a vote of 5 to 0.

Smanatha Smith provided the Board with an update on the Department's social media and recruiting activities. A motion was made by Mr. **JERNBERG**, seconded by Mr. **ARRINGTON**, to approve the report as presented. Motion passed by a vote of 5 to 0.
