

PUBLIC MEETING NOTICE

Notice is hereby given that **HARRIS-FORT BEND EMERGENCY SERVICES DISTRICT NO. 100** will hold a meeting on **August 4, 2026 at 6:00 p.m.**, at the following location in the District: **16005 Bellaire Blvd., Houston, Texas 77083.**

The District will consider and act upon the following matters:

1. Call meeting to order.
2. To receive public comment.
3. To review, discuss and act on financial matters, payment of District operating bills, payment of budgeted capital expenses and payment of operations funding pursuant to the service agreement with the Department.
4. To review, discuss and approve collection and appraisal value information as provided by the Fort Bend County and Harris County Tax Offices.
5. To review, discuss and propose the District's 2026 Tax Rate.
The District acknowledges the requirement of Government Code §551.043(c)(2) to prepare a taxpayer impact statement when reviewing and adopting budgets. However, no tax rate or budget has been proposed at this time with which to prepare the required information. Therefore, no Taxpayer Impact Statement is included.
6. To schedule a public hearing regarding the District's 2026 tax rate and the date of the meeting to adopt.
7. To review and take action on matters relating to an election to be held on November 3, 2026:
 - a. Approve an Order of Election under Texas Tax Code Section 26.07.
 - b. To review and take action to hold an election jointly with other jurisdictions.
 - c. To review and take action to contract with Harris County Elections Office for election services.
 - d. To consider and take action on such other Orders, Resolutions and related matters as required or appropriate to call for the District election
8. To receive an operations and financial report from Community Volunteer Fire Department, and to take any necessary action thereon, including to receive and approve the Department payroll and expense totals from the previous month and Department budget.
9. To review, discuss and act on matters related to operation of Westcom.
10. To review, discuss and act on matters related to District's website, social media and public education.
11. To receive an update regarding District Government Affairs and take any necessary action related to same.
12. To review and act on disposal of surplus equipment.
13. To review, discuss and act on acquisitions or needed repairs of District supplies, equipment, vehicles or apparatus, including funding.
14. To review, discuss and act on needed improvements or repairs to the District's facilities, including funding.

15. To review, discuss and take action on matters related to construction (current and proposed) projects, including funding.
16. To review, discuss and take action on matters related to real estate matters.
17. To review, discuss and take action on matters related to personnel, including compensation, benefits, retention and recruiting.
18. To review, discuss and take action regarding conference attendance and participation.
19. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.
20. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
21. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
22. To take action on matters discussed in closed session.
23. To discuss and take action to confirm the next regular monthly meeting date as well as any items that need to be on the next meeting agenda.
